Dear Arizona Helping Hands Family,

Thank you for taking an interest in the financial health of Arizona Helping Hands (AHH).

Since 1998, AHH has had a strong history of providing a broad range of services and since we narrowed our focus in 2014 to the foster care community, we have become the state's largest provider of essential services.

Our organizational infrastructure and program models have shaped our organization into a professional, innovative, and nimble human-centric entity. As a part of our strategic plan, we are committed to investing in strategies that focus on maximizing access to our services while keeping our mission at the forefront. These intentional changes align our programming and administrative costs with best practice standards as outlined by the Better Business Bureau. AHH currently stands with 81% program costs with 19% remaining to cover operational and fundraising costs.

Being good stewards and focused on financial solvency, the AHH Board of Directors approved spending investment dollars to reach foster children throughout the state as well strengthen internal systems. Strong ties with Native American Tribes and the Department of Child Safety (DCS) allowed AHH to nearly triple the number of families served - upward to 50 families a day. Two significant changes impacted both revenue and expenses:

- Revenue: programmatic policy changes required in-kind donations to be new and directly aligned with AHH's mission. This directly reduced the number of items received that were not mission centric.
- Expenses: re-imagined the service delivery model moving from appointments to open hours increasing the annual product distribution volume from 529,107 items to 867,778. Investment reserves were accessed to cover the additional product demand above and beyond donated items.

AHH's mission is to support the foster care community by providing essentials to benefit children in foster care. Our full commitment is to provide our services in a safe, human-centric environment, where our broad community (donors, volunteers, clients, and staff), can support families who open their hearts and homes to the more than 14,000 children in foster care. Our collaborative efforts throughout the State of Arizona are grounded in our why: we believe all kids deserve a chance to win!

The generosity of our donor community provides resources in the way of product and monetary support and for that, we are forever grateful.
